## Continuing Education Information

West Virginia licensed Social Workers may earn up to 19.25 contact hours by attending workshops in each time period, two networking sessions, both plenary sessions, and the Annual Meeting. Hours earned by related professions or those from out-of-state will vary according to their CE regulations. Attendance is required to earn hours.

NASW, West Virginia Chapter is a recognized provider of continuing education for Social Workers in WV and OH, the WV Certification Board for Addiction Professionals, the WVU Nonprofit Management Certificate Program and the West Virginia Board of Registered Nurses. NASW professional continuing education hours are also generally accepted for social workers licensed in DC, MD, KY, PA and VA. ### Ethics Hours for WV Temporary License Social Workers

Watch this space for a list of sessions that apply. WV Temporary License holders must earn 8 CE hours in Social Work Ethics every 2 years. Several workshops and at least two *Networking Sessions* will apply to this requirement. See session descriptions for the code 'ETH' to indicate relevance to this requirement. To insure access for others who need this credit, please schedule to take a few hours this year and come back next year to earn more.

### Psychopathology Hours for WV LICSW Candidates

### WV Licensed Professional Counselors – Application to be submitted; LPC Ethics

WV LPC license holders need to earn 3 full hours in Counselor related ethics every 2 years. Two workshops will be offered that meet this requirement. The length of these sessions will be extended to insure three full hours of instruction.

Please note that LPCs attending 3-hour workshops will earn 2.75-hours of CE credit for each because refreshment breaks cannot be counted as instructional time.
